

## Configuration of Ondal systems with the pCon.planner

To use pCon.planner including the data from the Ondal catalog, please do the following:


1. Create an organization account at pCon.login or transfer existing accounts to a shared organization
2. Purchase license(s) for pCon.planner Pro from EasternGraphics
3. Assign licenses as administrator
4. Install and use pCon.planner

The individual points are explained in detail on the following pages:

1. Create an organizational account with pCon.login or transfer existing accounts to a shared organization

### Case 1: You and/or people from your company do not yet have an account

If you do not yet have a pCon.login account, please create one using the following registration link:



### CASE 2: You or people from your company already have a pCon.login account

If you or someone else from your company already has an account, you should define a person among your company's pCon.planner users who will act as the administrator and invite the others to pCon.login. The (already existing) organization number of this person is then automatically the organization number of the company.

You can find your organization number when you log in under Overview - pCon.login (pcon-solutions.com).


## 2. Purchase a license

To access the Ondal data, you need a paid license of pCon.planner Pro. You can purchase these licenses directly from our partner EasternGraphics: [pCon.planner License – Ondal Customer – pCon solutions – Forms \(pcon-solutions.com\)](https://pcon-solutions.com)

Please enter your company's organization number (see point 1.) and the number of licenses you wish to purchase in the form. Your company's licenses will then be managed by you as the administrator and assigned to individual users. Please note that the administrator of your company needs to be defined first.

You will receive an order confirmation from EasternGraphics containing the download link to the pCon.update DataClient.

The licenses will then automatically appear in your pCon.login account of the organization in the "Licenses" tab.

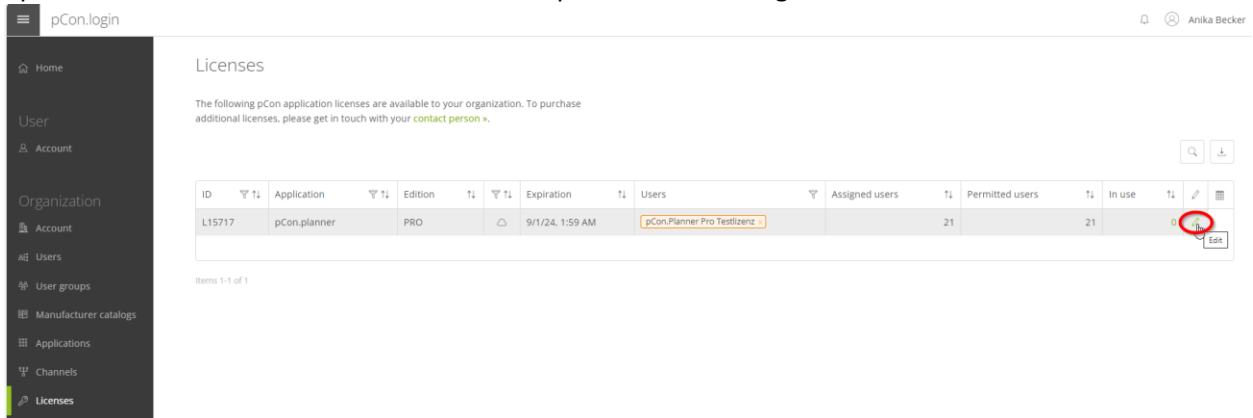

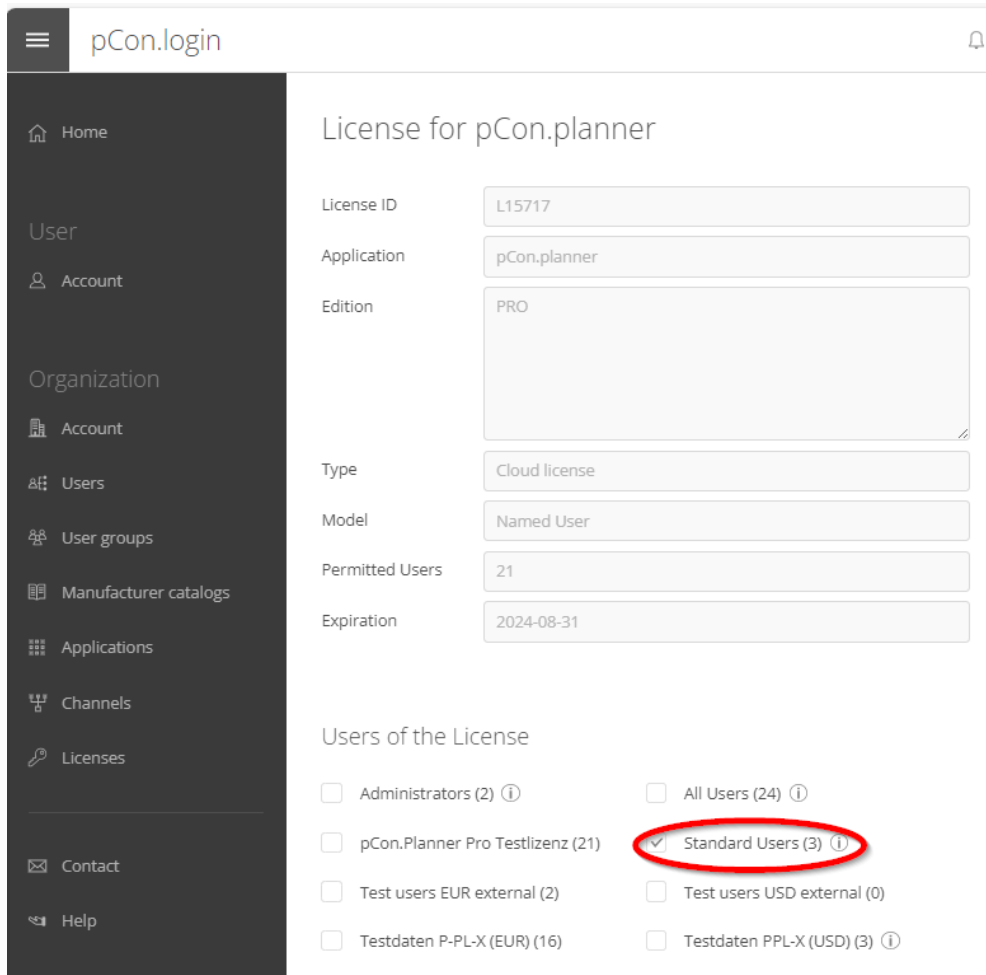

### 3. Assign license as administrator

To be able to use the licenses, you must assign the licenses to a group within the organization. To do this, open the “Licenses” tab and click on the small pencil on the far right of the license.



In the lower area under “Users of the License”, tick the “Standard users” box. This assigns the licenses to the automatically generated “Standard user” user group. Click on “Save” to apply the changes.



Note: Make sure that you have enough licenses available. You will be shown how many users the user group has and how many permitted users or licenses you have available

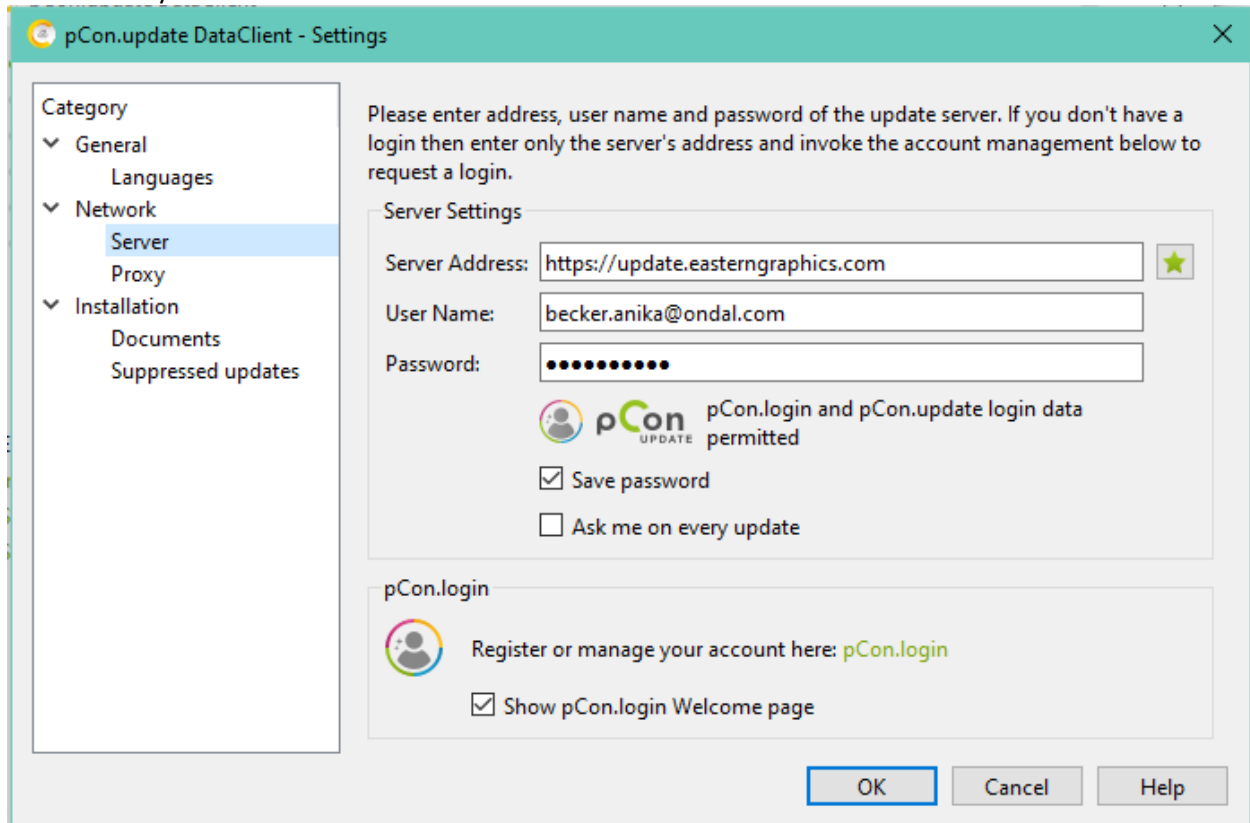

## 2. Install and use pCon.planner

First install the pCon.update Data Client. You received the download link in the order confirmation from EasternGraphics.

Open the pCon.update Data Client and log in with your login data for [pCon.login \(pcon-solutions.com\)](https://pcon-solutions.com)

Now follow the instructions of the pCon.update Data Client to download the data packages and software released for you.

After installation, you will find the pCon.planner Pro icon on your desktop. Open the software and start your first configuration. The first time you use it, you must enter your pCon.login user data. When you start pCon.planner, you will be prompted to do so.

You need admin rights for installation. The recommended system requirements can be found here:
